ESTABLISHED

MHEC was established in 1977 as a cooperative under MA Law to provide efficiencies and cost savings to its members (M.G.L., c. 15A, s. 24A). Its charter has since been expanded to include all New England states (CT, MA, ME, NH, RI, VT).

We pride ourselves on developing and managing our own contracts, offering transparency and trustworthiness.

COMPLIANT

Cooperative contracts like those provided through MHEC are an approved option for public procurement. All MHEC contracts are developed in a fair, open, and competitive manner. For our MA members, that means they are consistent with 30B. MHEC contracts have been independently audited and are compliant with all federal uniform guidance (EDGAR) regulations.

VALIDATED

MHEC contracts meet (and often exceed) generally accepted procurement best practices:

- Publicly bid in a fair, open, and competitive manner
- Bids are advertised in New England-based relevant publications
- Use specific purchase descriptions in the solicitation
- Provide for renewed competition
- Use a clear rule for award
- Use an appropriate comparative evaluation process
- Agreed-upon, pre-negotiated terms and conditions
